The Committee wishes to report that, to the best of its knowledge, the San Francisco Community College District is in full compliance with Article XIII A of the State of California Constitution.

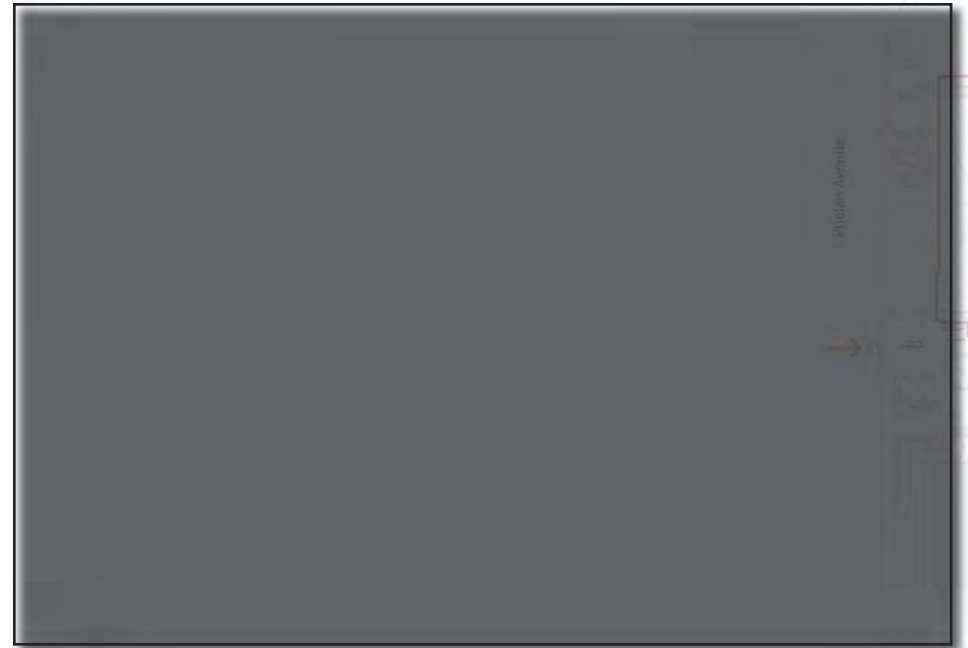
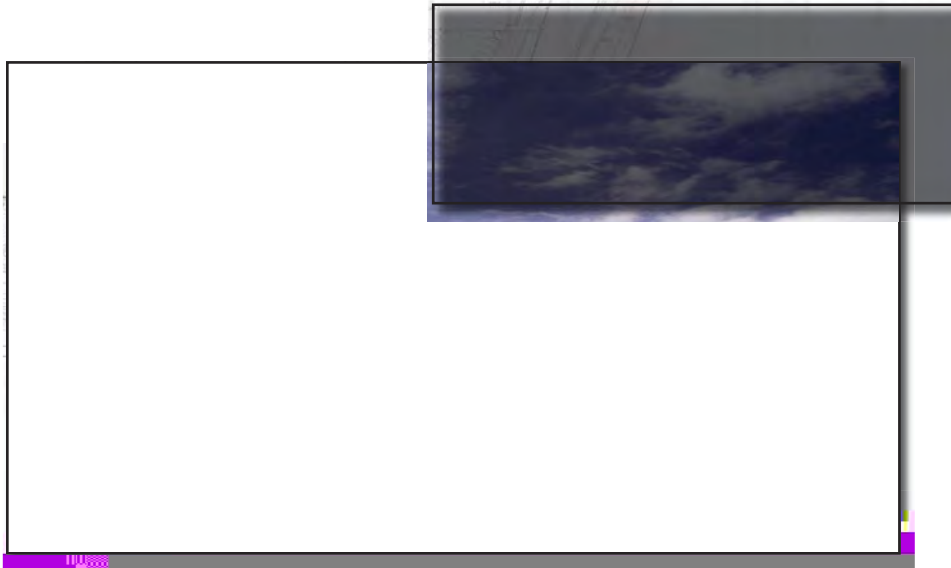
